#### **President's Report**

The outgoing President, Serena Kelly, submitted the below report for 2023:

It has been a pleasure to represent the European Studies Association of Australia and New Zealand (ESAANZ) as President for the 2023-2024 year, taking over from Associate Professor Gosia Klatt, as part of the rotation system between Australia and New Zealand.

For me, the success of ESAANZ rests on the support of the support of its members. #### **European Union Centre of Excellence - RMIT University**

On May 13, 2024, Melbourne will be hosting a significant event to commemorate Europe Day, celebrating a longstanding research and innovation partnership between the EU and Australia. The free event, set to take place from 11:30 am to 2:00 pm, will focus on the Horizon

Europe strategic plan for 2025-2027, showcasing the EU's global leadership in inclusive, public-funded research and innovation.

The panel discussion will feature prominent figures such as EU Ambassador to Australia, HE Mr. Gabriele Visentin, and experts from various research and innovation sectors, including Nishant Shandilya from EURAXESS Worldwide, Kate Finger from the Birchip Cropping Group, and academic leaders from RMIT University. Hosted by the EU Delegation to Australia, RMIT University EU Centre, the European Studies Association of Australia and New Zealand, and the Australian Institute of International Affairs Victoria, the event promises to be a cornerstone for future collaboration and innovation between Europe and Australia. #### University of South Australia

In the 25th episode of "Europe Now" by the University of South Australia's Jean Monnet Centre of Excellence, German Ambassador H.E. Ms. Beate Grzeski discussed the deepening strategic alliance between Germany and Australia. Ambassador Grzeski highlighted the significant collaboration across trade, culture, and politics, emphasising the importance of this partnership in addressing global challenges like climate change and geopolitical tensions. She noted Germany's focus on diversifying trade links and investing in Australian resources such as green hydrogen and critical minerals to achieve carbon neutrality. The ambassador also touched on managing global migration effectively within the EU framework and stressed the role of educational and cultural exchanges in fostering bilateral relations. Looking forward, she envisioned a robust partnership that leverages shared values and mutual interests to tackle future challenges. The full interview can be viewed <a href="here">here</a>.

#### **ANU Centre for European Studies**

On 23 April 2024, ANUCES hosted a lecture "Europe in the New World Order" by Michael Karnitschnig, Director for External Relations at the European Commission's Secretariat General, who talked about the changed configuration of the international security order as a consequence of Russia's invasion of Ukraine, and the evolving role of the EU as a global actor in geopolitics and geo-security. A seminar "Europe's response to Russia's invasion against Ukraine – a Japanese perspective" was delivered by Dr Atsuko Higashino on 27 March 2024. Dr Higashino provided an overview of the Japanese Government's evolving approach to Russia and discussed the competing views within Japan on a potential ceasefire and future support for Ukraine's reconstruction.

On 26 March 2024, ANUCES and the Foreign Policy Council "Ukrainian Prism" co-organised a roundtable "Global consequences of the Russian-Ukrainian war". They should address an important research problem or question, advancing an innovative theoretical or methodological approach, or a practitioner analysis of a contemporary policy issue or problem. Review Essays may be a review of a single recently published book, of a number of recent contributions to a particular debate, or may be a broader 'state-of-the-art' survey of a contemporary theme or debate.

## **Europe and Australia News**

# European Commission - EU-Australia Energy Cooperation: Enhancing Educational Opportunities and Research

During a significant visit to Australia, European Commissioner for Energy Kadri Simson, alongside Australian Minister for Energy and Climate Change Chris Bowen and Minister for Resources and Northern Australia Madeline King, emphasised the expansion of EU-Australia cooperation in the energy sector. Their joint commitment to accelerating the global clean energy transition under the Paris Agreement opens new avenues for educational and institutional growth.

Commissioner Simson highlighted the deep-rooted partnership between Europe and Australia, remarking, "As strategic partners sharing strong commitments to environmental sustainability and climate action, it is crucial for us to intensify our collaboration in these challenging times." The discussion outlined several potential areas for joint efforts, including the advancement of renewable energy technologies such as wind, solar, and particularly renewable hydrogen.

This enhanced cooperation is likely to have profound implications for educational institutions in both regions. Universities and research centres are expected to benefit from

increased funding for research projects focusing on renewable energy technologies and energy efficiency. This could lead to the development of new academic programs and training courses tailored to equip students with the skills needed in a decarbonising global economy.
